There just seems to be so much drama and in-fighting that I don't have the time or energy for. *Ghost Adventures* itself, at least initially, had a very rabid fan base that would pounce at a moment's notice. I found that out when I wrote what I thought was an innocuous article for this very newsletter, pondering how Zak and *Ghost Adventures* were able to get permission to investigate Bachelor's Grove Cemetery after dark. A day after the newsletter with that article released, I received an email which simply read:

So now people are claiming that Zak is involved in some back-room shenanigans to try and keep *Ghost Adventures* rolling along by getting shows he perceives as competition cancelled. And of course, now the allegations of *Ghost Adventures* faking evidence has popped up. To which I feel the need to ask, "why now?" Mind you, I am not defending Zak's alleged actions, mainly because I've never looked upon Zak Bagans, *Ghost Adventures*, or any paranormal reality TV show as anything more than forms of entertainment. As such, entertainment can never be elevated to the level of "evidence" simply because of things like editing, post-production, and, in all fairness, ratings. What I do find concerning is that the same people attacking Zak are the very ones who had earlier put him on a pedestal or modeled their own ghost-hunting group after him.

Add, rinse, repeat. We need to do better or at least acknowledge that all TV shows are for entertainment purposes only. Either that, or this cycle is going to continue, as least for the foreseeable future.

And for the record, I still do not rock.

# Episode Thirteen

This may come as no surprise, but I love spooky stories. While it's true that most of the ones I read are what I call "candy" (fun for the moment, but ultimately forgettable), occasionally I find one that has more meat on its bones. This is how I would describe *Episode* 

Thirteen by Craig DiLouie.

This novel is about a team of paranormal investigators in 2016 filming their thirteenth episode of a program they call Fade to Black. Their location is Foundation House, supposedly one of the most haunted locations in America. Back in the early 1970s a group of scientists with the Paranormal Research Foundation, or PRF, moved in and conducted human experiments attempting to not only make contact with spirits, but also "read minds, control objects remotely, travel out of their bodies, [and] know the future." It would seem that their experiments resulted in some very strange phenomena. However, no one truly knows the full scope of their work because they mysteriously vanished in 1972. What happened to them? What did they find?

Fast forward to 2016 and the Fade to Black team has arrived. Matt Kirklin (believer) and his wife Claire (skeptic & scientist) are in the lead, followed by Jake Wolfson (cameraman), Kevin Linscott (tech manager & former police officer), and finally Jessica Valenza (actress added to the show by producers to round out the team). Their goal is to spend 72 hours at the Foundation House, gathering as much evidence of the paranormal as possible, and hopefully solving the mystery of the missing PRF



scientists. What they experience over that time is enough to send their ratings through the roof.

But at what cost?

Told in a "found-footage" format, Episode Thirteen has all the intensity and intrigue that readers of spooky stories enjoy. Not only do we have plenty of paranormal activity, but we get to bear witness to the changes the characters go through as the days go by. We see their interactions, hear their thoughts, share their concerns and fears. Even though, in my opinion, the plot took a strange turn toward the end, overall, I found this novel an engaging read that's perfect for fans of paranormal television.

# THE SB7T SPIRIT BOX

Over the last several, months, I have become interested in obtaining specialized equipment that might have the potential to make our investigations more effective while increasing our ability to gather meaningful evidence. So when I ran across an ad promoting the P-SB7T Spirit Box for under \$100, I thought I'd take the plunge.

For those not familiar with spirit boxes, they are essentially transistor radios that continuously scan or "sweep" through radio frequencies. It is said that as it is scanning, ghost voices can be heard and, in some instances, investigators are even able to engage in two-way conversations with the ghosts.

One of the reasons I was intrigued with the SB7T was because The Ghosts Of Ohio already owns an SB7, so I wanted to see what the updates were with this new model.

Both models allow the user to choose between AM and FM and whether to scan the frequencies forward or in reverse. There is also the ability to adjust how fast the spirit box scans—the "Sweep Rate". Both also have outputs so you can incorporate earphones or attach an external speaker.

The biggest update to the SP7T is also where the "T" comes into play; temperature. The SP7T has an integrated temperature display that allows you to monitor temperature in Celsius or Fahrenheit. It also has something



called Ambient Temperature Deviation Detection (ATDD) built in, which is said to alert when the SB7T detects temperature spikes.

I tested the SP7T at home and all functions seemed to work fine. No, I unfortunately did not get any EVPs while I was testing it, but maybe that's a good thing. I'm looking forward to testing it out in the field by itself, as well as alongside the SP7 to see if they pick up the same thing or if one is better than the other. Stay tuned!

## GS2 LASER GRID SYSTEM

Quick update on our testing out the GS2 Laser Grid system: Mark continues to run it through its paces at his top-secret lab, using bags of ice to try and determine the range of temperature changes the GS2 can detect and how quickly. We even took it out for a quick test run on a recent investigation, which will be featured in an upcoming book (whoops, did we just let a secret out?).



Right now, it appears as though the GS2 does do what it claims to, albeit its range of sight is much better suited for a small, enclosed area as opposed to the wide spaces its often seen being used in on several ghost reality TV shows.

# DEADLY DRIVING, GHOSTLY VEHICLES



When people think of ghosts, they think humans, whether they are moaning and dragging chains up the stairs or a family member visiting. Not many think of vehicles, yet they have been reported for centuries, with one of the most famous, the Flying Dutchman, being at the forefront. Here is just a handful of reported ghostly vehicles.

#### Stagecoaches

There have been a number of ghostly stagecoaches seen, but rarely are they backed up by fact. One that has been witnessed in Anza Borrego State Park in California is. In the 1860's, a stagecoach that was running towards the Vallecito Station was held up and the driver was killed. The coach can be seen travelling in the location of that old station.

Also in California, another phantom coach is seen in Santa Ynez, on the road west to Solvang. This coach is reported as being black, with 4 black horses. Yet research finds no reason for this supposed haunting.

#### Trains

Train ghosts seem to be more plentiful. President Lincoln's funeral train is one of the more famous, seen and heard by many as it passes along his funeral route. But another interesting sighting is based on the 1891 Bostian Bridge crash in North Carolina. In this case, the train jumped the tracks on the bridge at around 3am and fell to the valley. Many perished in the crash. In 1941, a traveling couple had car trouble near the bridge. The man went to get help while his wife waited at the car. As the clock moved to 3am, she saw a train approach the bridge, then jump the track and fall into the valley. She headed to the wreck to help, following the screams of the victims. When she realized she needed more help, she climbed back to the car just as her husband arrived with another man. She

yelled at them to follow her because a train had crashed, but as they got there, the valley was silent, with no sign of a wreckage. The local who had come to help told them about the 1891 crash.


Finally, a bizarre report comes out of The Dragoon Mountains in Arizona. A phantom train is heard and seen travelling there between the mountains and Wilcox, Arizona The only problem is that there has never been a train route in that area!

#### Ships

Ships are a little harder to find, since when you research 'ghost ships', you end up getting stories of abandoned ships, not actual ships that are ghosts. But I was able to find a few. In the United States, the majority are seen in and around the Great Lakes. The Bannockburn disappeared in 1902 on Lake Superior but is still seen sailing the lake. The Cornelia B. Windrate vanished on Lake Huron in 1875 but is also still reportedly seen from time to time. In 1892, the W. H. Gilcher sailed from Buffalo NY, headed toward Milwaukee, WI. On Oct 28th, it was witnessed by another frigate coming into a storm northwest of North Manitou Island in Lake Michigan. It never made it out, and bodies along with a W.H. Gilcher life preserver and other

wreckage were found in and around South Manitou Island. To this day the ship has been reported coming out of a fog bank around Mackinac Island. The Western Reserve sank offshore on Lake Superior on August 30, 1892, under similar circumstances. It has been seen, but most people report just hearing disembodied voices.

#### Cars

And then there are cars. From the sounds of James Dean's 1955 Porsche 550 Spyder slamming into the car driven by Donald Trunupseed on what is now Highway 46 near Cholame, CA, to phantom menaces, these are seen quite frequently. Here are just 2 examples of what you might encounter on your next road trip.

Near Shiprock, New Mexico, a ghost car appears on US Highway 666, otherwise known as the highway to hell. This nasty car attempts to run other cars off the road. But as is the case with most ghost cars, there doesn't seem to be any evidence to back up the story.

But this one is a little more detailed: In the 1940s, a car driving near Ashboro, North Carolina was recklessly trying to pass other motorists on Route NC 49. As it approached a hill while attempting to pass, it got caught between the car it was passing and a truck that was coming down the hill. The car tried to swerve to avoid the truck, but was clipped, sending it into a tree. Since then, people have reported car lights speeding up behind them, then moving to pass. As the speeding lights pull up alongside, no driver can be seen, and the car vanishes.

Many other witnessed ghost cars are lights that chase you or come towards you, which sounds a lot like our Oxford Ghost rider. So on your next road trip, don't just take a walking ghost tour of the city you are in, look around. Those vehicles you see and hear might not actually be there...


