Ghost Stories: My BLOODY Valentine—From Gangsters to Ghosts

What would become known as one of the bloodiest days in gangland history began innocently enough on the morning of Thursday, February 14th, 1929.

Several members of Bugs Moran's North Side Gang began arriving at the SMC Cartage Company building at 2122 N. Clark Street in Chicago. By 10:00 AM, there were seven men inside the building, five of which were Moran gang members-Peter Gusenberg and his brother Frank, Adam Heyer, Albert Kachellek (aka: James Clark), and Albert Weinshank. The other two men in the building were Reinhart Schwimmer, who was considered more of a groupie than an actual member of the gang, and mechanic John May.

Around 10:30 AM, two cars similar to those driven by Chicago detectives pulled up in front of the SMC Cartage Company building. Two men dressed as police officers left the cars and entered the building while two other men, dressed in civilian clothes, waited outside.

From what is able to be reconstructed, the police officers made it appear as though the building was being raided and made all seven men inside line up against the rear North wall of the building, with their faces towards the bricks. From the evidence, all seven men believed the raid was real and made no attempt to resist.



Once the men were lined against the wall, the two men who had been waiting outside entered the building. At that point, those two men, along with the two police officers, opened fire, using a combination of multiple Thompson submachine guns and shotguns. It is estimated that over 70 shots fired were fired in the assault.

When it was over, the policemen led the two men in civilian clothes to the cars at

gunpoint, apparently to give the impression to anyone hearing the noise that things were under control. The four men then got in their cars and disappeared.

Several hours later, police were called to investigate the reports of a dog crying and howling. When they arrived and entered the building, they found a bloodbath unlike anything they had ever seen. Six of the seven men were dead from multiple gunshot wounds. Frank Gusenberg was still clinging to life, but he would succumb to his wounds several hours later. Interestingly enough, his last words were said to have been "nobody shot me." The only witness to survive the slaughter was John May's dog, Highball, whose mournful wails had first alerted police to the building.

So what was the cause of what became known as the St. Valentine's Massacre? It would appear as though it was the result of bad blood between Bugs Moran's North Side gang and Al Capone's South Side gang. The two gangs had been battling for control over

Chicago's bootlegging business and there had been several attempts to knock off members of each gang. Even though no one was ever convicted of any of the murders, most historians believe that Capone ordered the hits and wanted Bugs Moran to be killed, too. It is thought that lookouts stationed across the street mistook one of Moran's men for Moran himself and prematurely called for the massacre to take place. As for Moran, he was on his way to the Cartage Company, but arrived shortly after the two bogus police officers had already entered the building and had his driver keep going to avoid being arrested himself.

It should come to no surprise to anyone that the scene of such violent death would become haunted. Indeed. shortly after the massacre, rumors began circulating that the Cartage Company building was haunted. Strange sounds, including those of gunfire and men screaming, were reported coming from inside the building, as was the ghostly

Beyond the Technology: Darrin's Tools of the Trade



Past articles have been about tools, both technical a n d non-technical, that can be bought and learned how to use. But, in this article, I will be discussing the most important tool investigators can use — themselves.

We just need to learn how to interpret what our bodies are telling us and realize that we can also easily misinterpret it as well.

We have all been in situations where we get scared, excited, or nervous and

our senses really seem to become heightened from an adrenaline rush. We think we can hear, see, and maybe even smell things better. Our hearts start to beat faster and our breath comes a little quicker. When this happens during an investigation, we have to remember several things — and that can be hard to do.

Although we are in this excited state, we have to try to keep our heads and remember that we are still in control. We have to realize that while we are excited, we can try to use the information our bodies are giving us to our benefit.

There is nothing wrong with getting excited about what we are doing and what is going on, that's why we got into this field. The main trick is to try and not let ourselves get too carried away and to use the information our bodies are giving us.

As you start an investigation, try and remain as calm as possible. Your breathing and heart rate will probably already be higher than normal. As the evening goes on, try to pay attention to your body when something happens and see if your breathing and heart rate increase before or after things occur. Since no one really knows what a ghost is, or how it can manipulate the

environment, we really don't know how or if it can affect our bodies. Some people seem to be sensitive to EMF fields and can get a feeling of nausea when they are exposed to higher fields. If that's the case, then shouldn't it also be possible that people could experience higher pulse and breathing rates if they are around a ghost that is trying to manifest itself? The big question we have to ask is-did our breathing and heart rates go up because of the situation we were in or was it because of some environmental effect caused by a ghost? If the latter is the case, what was happening that made our pulses and breathing rates increase? Use your

Rely on your senses: conducting a complete investigation requires more than

equipment to try and verify that there is an EMF spike or that the temperature is dropping.

We also need to pay attention to our senses, but once again, we have to keep ourselves in control. I don't mean that vou shouldn't be excited, just keep in mind that you are worked up and try not to let yourself get carried away. Try to be aware of how you feel at the start of the investigation so that as it goes on, you can tell if you start to feel differently. At some point, do you feel as though things are closing in on you? Do you feel like something else is in the area with you? Or, do you feel a prevailing type of emotion? Is your

hearing really that much better or are you hearing the beat of your own heart? Always try to remember that our minds can take information our senses collected and interpret it in a totally different manner than it truly occurred.

For example, if you go into a room and suddenly feel a heaviness, make sure you use your equipment and see if you are getting any unusual readings. It could be that you have gone into an area that has been closed up for a while and has a slightly higher temperature and stale air, and in your heightened state of awareness, you may have misinterpreted your senses. You could think that there is a presence in the

> room with you instead of realizing the feeling is caused by normal atmospheric changes.

> When getting ready for an investigation, know that we all have varying levels of excitement and that we all will deal with it in different ways. For some, this might never be more than just a pure adrenaline rush from doing something fun. While for others, it may be something that can be used to the benefit of the overall investigation.

> Finally, if you haven't gotten the message already, remember to always use the equipment you have to try

and verify what you are experiencing.

There is no way anyone will accept as evidence an investigator's feelings from the time an event was experienced. But, if we can show some kind of correlation between what we were feeling and similar unusual readings with our equipment, we might be able to offer another form of validation for any paranormal situation that might be occurring. It's not scientific evidence, but it may show that we can use our own bodies as a tool. Most importantly, use your head and have fun.

wailing of a dog. Stranger still was that people walking their dogs past the building claimed their dogs would suddenly pull away from them and refuse to walk in front of it.

But by far, the strangest ghostly report to come out of the St. Valentine's Day Massacre centers on no other than Al Capone himself. Though he was never formally charged with anything related to the murders and maintained his innocence until his death, Capone was still tormented by the ghosts of those killed. In particular, Capone was convinced that the ghost of Albert "James Clark" Kachellek was following him. When Capone was doing time in Alcatraz on an unrelated charge, fellow inmates reported that Capone would often keep people up at night repeatedly screaming "Jimmy, leave me alone!" After leaving prison, Capone's bodyguards would often come rushing into Capone's bedroom upon hearing him scream. They would find Capone cowering in the corner, claiming that "Jimmy's ghost" was after him. Capone supposedly went so far as to hire a psychic to try and get the ghost to leave. She was apparently unsuccessful because until his death, Capone kept looking over his shoulder for Jimmy's ghost.

As for the haunted building itself, in the late 60s, the Cartage Company building was being torn down when Canadian businessman George Patey



stepped forward and purchased the entire bullet-ridden North wall of the building, all 414 bricks of it. Patev had the wall taken apart brick-by-brick, numbering each one along the way so it

could be reassembled later. Then the entire wall was shipped back to Canada. Patey tried putting the bricks on tour

and eventually reconstructed the wall as part of a themed restaurant. In the late 1990s, Patey attempted to sell the entire wall, but was unable to find a buyer and instead decided to start selling individual bricks. According to legend, some of the brick buyers returned their purchases, claiming they were cursed and had brought nothing but bad luck since the bricks had arrived in the buyers' homes. Patey himself passed away in 2004. The current location of any of the bricks that remained in Patey's possession remains a mystery.
